**IN THE MATTER of an application by Enbridge  
Gas New Brunswick to extend the Development  
Period and Deferral Account Recovery Period**

**ORDER**

**WHEREAS** Enbridge Gas New Brunswick Limited Partnership, as represented by its general partner Enbridge Gas New Brunswick Inc. ("EGNB") filed an application and information in support of the application on October 8, 2004 with the New Brunswick Board of Commissioners of Public Utilities ("the Board") to extend EGNB's Development Period and Deferral Account Recovery Period;

**NOW THEREFORE IT IS ORDERED THAT:**

1. A Pre-Hearing Conference shall be held at the Board's offices, 15 Market Square, Suite 1400, Saint John, New Brunswick, on Wednesday, the 10<sup>th</sup> day of November, 2004 commencing at 10:00 o'clock in the forenoon, when and where interested parties may attend and make representations as to the type of proceeding, the procedure to be followed in respect of the proceeding and as to any other relevant matters.
2. Notice of the holding of the Pre-Hearing Conference in respect of the procedure the Board intends to follow to facilitate the participation of interested parties, shall be published in the form or substantially in the form attached hereto marked "A", in either the English or French language as may be appropriate having regard to the principal language of publication, once in each of the following papers:

The Times and Transcript (Moncton)  
The Daily Gleaner (Fredericton)  
The Telegraph Journal (Saint John)  
L'Acadie Nouvelle (Caraquet)

The date of publication shall be on or before the 16<sup>th</sup> day of October, 2004 in each paper.

3. A copy of the Application, the information in support of the Application and the Board Order will be placed on file for examination by interested parties during normal business hours at the offices of

the Board, EGNB's offices at 440 Wilsey Road, Suite 101, Fredericton, New Brunswick, and on EGNB's web site at [www.amazingenergy.ca](http://www.amazingenergy.ca). Persons who wish to receive copies may do so by contacting Shelley Black as noted below.

4. Persons wishing to participate as intervenors must do so in writing, no later than 12:00 noon on Friday, November 5, 2004 by notifying the Board at the address below and EGNB, Attention: Shelley Black, 440 Wilsey Road, Suite 101, Fredericton, New Brunswick, E3B 7G5; Tel: (506) 457-7751; Fax: (506) 457-7753; Email [shelley.black@enbridge.com](mailto:shelley.black@enbridge.com) and such persons shall:
  - (a) Set out the name of the person and any authorized representative of the person and the mailing address, civic address, telephone number, and any other telecommunications numbers of the person or the person's authorized representative;
  - (b) State the official language in which the person wishes to be heard;
  - (c) State the preference for the type of proceeding (written or oral), along with reasons;
  - (d) Establish that the person's interest justifies status as an intervenor in the proceeding.
5. Pursuant to Section 96(3) of the Gas Distribution Act, 1999, EGNB is exempted from the requirements of the Gas Distribution Rules of Procedure Regulation and the Gas Distribution and Marketer's Filing Regulation with respect to this proceeding.
